The Woodsville – Wells River Rotary Club awards four \$1,000 scholarships to local students each year. Students graduating from Blue Mountain Union School, Oxbow High School, River Bend Career & Technical Center or Woodsville High School who intend to attend college in the fall are eligible. Home schooled students from the enrollment area of any of these schools are also eligible.

Rotary Club Scholarship Requirements

1. **Completed application must be received by May 17, 2010**
2. To be eligible, the student must rank in the top 1/3 of his class.
3. The student must graduate during this school year.
4. Student must intend to attend a college-level school, starting this year, with the intention of earning a degree or professional certificate.
5. Student must show a strong history of, and potential for continuing, community service.
6. **Three letters of recommendation.** Ask prospective letter writers promptly, other students are asking too.
7. **A transcript from your school.** Your guidance counselor will help you – if you ask.

The Rotary Club works hard to keep your information confidential. All financial information is destroyed promptly after the Club has selected scholarship recipients.
